1) The organizing authority is Grapevine Sailing Club (“GSC”).

2) Rules:

- a. The 2013-2016 International Sailing Federation (ISAF) Racing Rules of Sailing (RRS) [<http://www.sailing.org/documents/racingrules/index.php>], the prescriptions of the United States Sailing Association, and applicable class rules, except for any of those that are altered by these sailing instructions, will govern these races.
- b. The 2016 GSC Series Race Sailing Instructions apply except as amended by this Notice of Fall Series. The Sailing Instructions are available at [GrapevineSailing.org](http://GrapevineSailing.org) on the Racing page under “Race Docs and Results”, and on RegattaTech by clicking on the Documents tab on any page for this event.
